Sri Hivare Nisarg Gautam, I.A.S., Deputy Commissioner cum Chairman D.R.S.C. Hailakandi, welcomed all the members present and presided over the meeting.

Sri Aloke Kumar Nandy, Executive Engineer, PWD (Roads), DTRD, cum member secretary revised the agendas of the meeting and Chairman initiated the discussion by following up on the resolutions undertaken in the previous DRSC meeting held on 20-02-2023. Consequently following are the agendas taken up in this meeting for implementation.

1	PWD (Roads), PWD NH, Police	<ul style="list-style-type: none"> The report of Joint Verification Team formed to inspect the accident and vulnerable spots have been reviewed with their causes and remedial measures presented by the team. To submit the cost involvement/estimate amount of the remedial measures of each identified spots by the concerned deptt. and to implement the same. And if the fund is not available with the concerned deptt., it may be forwarded by the DRSC to the competent authority for sanctioning. The PWD (Roads) Deptt. is asked to provide speed breaker on feeder road at junction point with NH/primary road at the identified spots of the Joint verification report within 30 days, and the list of proposed works should be tabled before the Chairman within 7 days. Police is asked to evict the make shift bazar on NH at Katlicherra Bagan By-Pass where a fatal accident was recorded in the past.
2	DRM, iRAD, NIC	<ul style="list-style-type: none"> NIC to organise a session on training of stakeholders for proper reporting on online portal iRAD within 7 days at DC conference hall.
3	Police Deptt.	<ul style="list-style-type: none"> Police Deptt. is to ensure attendance of IOs or OCs from respective Police Stations to the training session to be organised by NIC on iRAD. The OCs and IOs of police stations can also bring their respective PS data entry operators alongwith to this training session for better understanding of the process of data entry in iRAD portal.
4	PWD NH Deptt.	<ul style="list-style-type: none"> Necessary signage should be installed at Jacobpur where accident was recorded under Ramnathpur P.S case No. 19/2022 in the straight stretch. SCHOOL signages to be provided on both ends of Manipur HS and Manipur Model School within 15 days. To install signages at the identified gaps in both English and local languages if the guideline permits. Write a letter to the Commissioner & Special Secretary, Public Works Building & NH Department, Assam enquiring about whether road safety measures can be adopted in the ongoing projects under Hailakandi district before completion of surface works on all identified vulnerable and accident spots by this committee.

5	Joint Director of Health Services/ District Manager 108 Mrityunjoy Emergency Services	<ul style="list-style-type: none"> To cross check the data of response time of 108 ambulance services presented on today's meeting. Concern expressed over the greater number of cases transported by private vehicles over the 108 services during Emergency. The District Manager of 108 Mrityunjoy Emergency Services was cautioned to improve the 108 ambulances service in cases where referrals are made from S.K. Roy Civil Hospital to SMCH, Silchar.
6.	Member Secretary, DRSC	<ul style="list-style-type: none"> Instructed the Member Secretary, DRSC to issue showcause letter to the District Manager 108 Mrityunjoy Emergency Services Hailakandi to explain the larger role of private vehicle service over 108 services ambulances in emergency cases.
