The interested firms/individuals may submit the tender document complete in all respects to the NIC, O/O the Deputy Commissioner, Hailakandi within 12/01/2023 up to 3:00 P.M.

The Deputy Commissioner, Hailakandi will not be responsible for the postal loss/delay.

The conditional bids shall not be considered and will be out right rejected in very first step.

All entries in the tender form should be legible and filled clearly. No overwriting or cutting is permitted in the Bid form. The bid shall be opened on last day of tender submission at 4:30 P.M. in the Office Chamber of the Addl. Deputy Commissioner (Nazarat), Hailakandi in presence of the representatives of Tenderers, if any wish to present on spot at that time.

The cost of the tender is nil. The tender documents are not transferable.

The tenderer shall submit the following with the bid :-

- Bank account details (Bank Name, Branch, Account No., IFSC Code).
- Experience certificate, if any.
