

Minutes of the District Development Committee (DDC) Meeting for the month of September, 2022 held on 07-09-2022 at 11.00 A.M. in the Conference Hall of DC's Office, Hailakandi.

Members Present : As per Annexure -'A'.

The meeting was presided over by the Deputy Commissioner, Hailakandi. At the outset, he welcomed all the members present in the meeting.

Thereafter, the Deputy Commissioner reviewed the progress/ achievement of development schemes department wise and following decisions were taken:

1. AGRICULTURE:

- The DAO informed that e-KYC done so far is 40895 (91%) and total land records uploaded is 15460 nos. In this regard, the Deputy Commissioner directed DAO to upload all pending applications received under self registration at the earliest, collect the pending forms from the Circle Officer and upload the same. The DAO was also directed to complete the process of pending Aadhar authentication and e-KYC immediately.
- Regarding PMFBY, the DAO informed that target for Rabi is yet to be received.
- On a query from the Deputy Commissioner, the DAO informed that there are 36 nos. of retailers of fertilizers in the district. For Tea Garden area person having requisite qualification can apply for retailership for 1-2 or more Tea Garden.
- Regarding establishment of Community Canning and Training Centre, the Deputy Commissioner requested DAO to pursue the matter with the concerned agency for support to run the centre immediately.

(Action : DAO, Hailakandi)

2. HEALTH:

- The Deputy Commissioner directed the DFO to issue NOC by 8th Sept., 2022 for construction of Health Sub-Centre at Bagacherra Forest village.
- On a query from the Deputy Commissioner, the Jt. Director, Health Services, Hailakandi stated that total ANC registration is 7227. Further, Jt. Director informed that ANC 1st Trimester registration is 6275 (86.83%) and 4th ANC checkup is 4737 (65.55%).
- The Deputy Commissioner also asked to submit the list of maternal death and child death to ADC (Health) at the earliest.
- The Deputy Commissioner desired to know the status of shifting of LALA hospital for construction of new building of LALA CHC. The Jt.DHS informed that, as per plan all shifting done except OPD, Registration counter and Pharmacy. As per earlier discussion one shed was suppose to be constructed by contractor for shifting of OPD and registration counter which is yet to be completed. So, Deputy Commissioner instructed EE, PWD (B) to complete the work within 5 days i.e. within 12th Sept, 2022 and after completion, the Jt.DHS will ensure smooth shifting the OPD, Registration counter and Pharmacy immediately. The Deputy Commissioner also instructed ADC (Health), to visit LALA CHC on 14th Sept,2022 for compliance.

(Action : ADC (Health, EE, PWD (B), DFO and Jt. Director, Health Services, Hailakandi)

3. PWD (Building):

- On a query from the Deputy Commissioner, EE, PWD (Building) informed that the construction of LMO Plant at S.K.Roy Civil Hospital, Hailakandi will be completed within Oct.,2022.
- Regarding ITI Kuchilla, the EE informed that work of the ITI will be completed by this month.
- Regarding progress of Sevakunja under Untied fund, the EE PWD (B) informed that, piling works have been completed and physical progress is 20%.
- The EE stated that work of Model Women College is going on and progress is 25%.
- The Deputy Commissioner directed EE to submit the contour map by 12th Sept., 2022 for the scheme "Imp. of Stadium at DSA" under CSR. The DC also asked the EE to ensure timely completion of all the ongoing projects

(Action:- EE, PWD (Bldg), HDTB, Hailakandi)

4. PWD (Roads):

- On a query from the Deputy Commissioner, the EE PWD (R) informed that under Assam Mala 21 K.M. road is covered. In this regard, joint survey and cost assessment already done and land assessment 70% completed.

(Action:- EE, PWD (Roads) HDTR, Hailakandi)

5. Water Resources:

- The Deputy Commissioner expressed displeasure over the progress of works.
- As per report submitted by the EE, all the ongoing schemes are to be completed by Oct., 2022. But, the representative of EE present in the meeting informed that the schemes will be completed by Dec., 2022.
- On a query from the Deputy Commissioner, the official present in the meeting could not give proper reply about the level of water which is suitable for construction of the scheme viz: "Immediate measures to dyke along L/B of river Katakhal from Bishnupur to Gaglacherra for restoration of damages occurred at Jushnabad Part II" under SDRF for 2020-21. The Deputy Commissioner directed the EE for assessment of water level immediately. The DDC was requested to depute Assistant Commissioner for assessment of water level.

(Action:- DDC and EE, Water Resources, Hailakandi)

6. PHE:

- The EE PHE informed that against the target of 63107 nos. of FHTC for the year 2022-23, 2681 nos. has been completed so far.
- The, EE, PHE informed that the work in 140 nos. of rural school and 27 nos. of AWC is in progress and expected to be completed by Oct., 2022. The Deputy Commissioner expressed concern over the slow progress of work in rural Schools and AWCs and directed EE to cancel the work order and blacklist the contractors.
- Regarding issues related to AWCs, the Deputy Commissioner requested DDC to sort out the problem with the help of CDPOs.
- The Deputy Commissioner instructed ADC, i/c JJM to conduct meetings with railway officials and APDCL to know the process of obtaining railway permission for crossing of 33 KVA electrical HT line for the intake point of Greater Algapur Hailakandi large multi village water supply scheme.

(Action : ADC, i/c JJM, EE, PHE, Hailakandi and AGM, APDCL)

7. LDM:

- The Deputy Commissioner requested LDM to sort out problem faced by the following departments:
- **Education:** The ADC (Education) informed that, Bank A/c for students are to be opened within 10th September/2022.BUT AGVB Bank refused with the plea of shortage of staff.
- **DI&CC:** GM DICC informed that 27nos of applications under PMEGP are pending with AGVB Bank.
- **Agriculture:** DAO informed, KCC applications forwarded to bank are yet to be disbursed.
- **NULM:** DPM informed, SHG Bank Linkage are pending at different bank branches.
- **Khadi Board:** D.O.informed that, out of 9 nos applications sponsored to Banks 5 nos have been sanctioned by Bank.
- **Handloom & Textiles:** The Asstt. Director informed that 8 nos of proposals are pending at AGVB Bank.
- **ASRLM:** The DPM informed that, all SHG member's individual bank a/c needs to be Aadhar seeded
- The Deputy Commissioner asked all departments to submit line list of pendency in (excel sheet) to LDM so that, these could be taken up with concerned banks. The Deputy Commissioner also requested LDM to instruct the all concerned bank branches to extend full cooperation regarding opening bank a/c of students, Aadhar seeding, SHG credit disbursement, etc.

(Action : LDM, Hailakandi)

8. Irrigation:

- The EE informed that out of 270 nos of STW, 159 nos are functional. The DDC will depute Magistrate for random verification of STWs.

(Action:- EE, Irrigation,Hailakandi)

A.H&VETVY:

- The Deputy Commissioner expressed displeasure over the slow progress of 4 nos. of work related to A.H & Veterinary department under Aspirational District Programme being executed by Construction Committee.
- The Deputy Commissioner directed the Dist. Veterinary Officer to submit progress of works under ADP regularly and informed that, he will visit the work site of the schemes.
- The DVO informed the house that, to prevent further spread of African Swine fever virus from the village Appin Grant under Katlicherra Development Block restrictions have already been imposed culling have been done on 4/8/2022 as per locations identified by C.O., Katlicherra. The Deputy Commissioner directed the DVO to keep vigil so as to prevent further spread of the disease in other parts of the district and also requested CEO, Zilla Parishad , Hailakandi to alert the PRLs for creating awareness in the locality.

(Action: Dist.Vety.Officer, Hailakandi)

10. APDCL:

- Regarding exorbitant electricity bill issued against defunct BLC building at Katlicherra to the DAO. The Deputy Commissioner directed the AGM, APDCL to look into the matter and if necessary to disconnect the electrical connection.

(Action: AGM, APDCL, Hailakandi)

11. Labour:

- On a query from the Deputy Commissioner, the Labour Inspector informed that Aynekhal T.E. disbursed the bonus and for other Tea Estates the same is yet to be done. In this regard, Labour Officer stated that meeting is scheduled on 7th Sept., 2022 regarding payment of bonus.

(Action: Labour Officer, Hailakandi)

12.PWD (NH) :

- The EE, PWD (NH) informed that work of the Dhaleswari bypass will be completed by Feb., 2023.

(Action: EE, PWD(NH), Hailakandi)

13. Sports:

- The District Sports Officer informed the house that 6 bighas of land is required for establishment of Swimming Pool cum Gym and also stated that, Sports scholarship has been launched recently for players who have participated at State and National level.

(Action: ADC (Rev), Hailakandi & District Sports Officer, Hailakandi)

14. NULM:

- The DPM, NULM informed that 4 nos. of Area Level Federation (ALF) is pending at Co-operative Society, Hailakandi since last 4 months. The Deputy Commissioner requested DDC to resolve the issues immediately in consultation with ARCS, Hailakandi.
- The DPM also informed about the pending status of SEP (I), SHG Bank linkage and PMSVANidhi loans at different bank branches. The Deputy Commissioner instructed LDM to disburse all the pending loan applications within 15 days.

(Action: DDC, ARCS, LDM and DPM, NULM, Hailakandi)

15. ASRLM :

- Regarding SHG credit linkage, the DPM,ASRLM Hailakandi informed the house that, except CBI , Panchgram, SBI Monacherra , Union Bank Katlicherra, all other bank branches had extended their support for the same.
- The Deputy Commissioner, Hailakandi asked the LDM to instructed the concerned bank branches for disposing all pending loan proposals and should be monitored on regular basis.

- Lala : E.O. Lala, MB informed that, out of total 1154 no. of beneficiaries under PMAY(Urban), 774 nos are completed.
- Hailakandi : E.O. Hailakandi MB informed that, out of total 2877 no. of beneficiaries under PMAY(Urban), 1061 nos are completed.
- The Deputy Commissioner directed both the E.Os to ensure proper and timely implementation of the schemes and collection of property tax.

19. ADP:

- The ADC (ADP) requested concerned district heads of department to submit proposals under Aspirational District Programme immediately.

(Action: District Heads of Department)

20. Celebration of District Day:

- The DDC, Hailakandi informed the house that as per Govt. notification District Day will be celebrated on 1st October/2022(the day when the district was established). In this connection, the DDC requested all departments to participate and extend cooperation for celebration of the day in a befitting manner by organizing Rally, Seminar, various competitions, Inauguration of schemes, etc. For smooth & effective management of all such events Sub Committees, Cells will be constituted and notified. The Detail plan will be chalked out by ADC, (Nazarat) in consultation with DC/DDC/CEO, Zilla Parishad, Hailakandi which will be shared with all shortly.
